

NOTICE OF PUBLIC HEARING BEFORE THE PLAN COMMISSION
OF THE VILLAGE OF TOWER LAKES
TO CONSIDER PROPOSED AMENDMENTS TO THE
VILLAGE OF TOWER LAKES VILLAGE CODE AND TO THE
VILLAGE OF TOWER LAKES ZONING REGULATIONS WHICH ARE PART THEREOF

NOTICE IS HEREBY GIVEN of a public hearing to be held before the Plan Commission of the Village of Tower Lakes to consider amendments to the Village of Tower Lakes Village Code and to Title 10, "Zoning Regulations", which is part thereof as follows:

HEARING DATE AND TIME: Wednesday, December 11, 2019 at 7:00 p.m., or as soon thereafter as the agenda permits.

PLACE OF HEARING: Village of Lake Barrington Village Hall, 23860 N. Old Barrington Road, Lake Barrington, Illinois, 60010.

NATURE OF HEARING: To consider the following amendments to the Village of Tower Lakes Village Code, including but not limited to Title 10, "Zoning Regulations", thereof, relative to the keeping of backyard chickens, coops, runs, and other related matters, and specifically, to:

- (1) Chapter 1, "Administrative Provisions", of Title 10, "Zoning Regulations";
- (2) Chapter 4, "Districts Enumerated", of Title 10, "Zoning Regulations"; and
- (3) Chapter 6, "General Requirements", of Title 10, "Zoning Regulations".

The following other related provisions of the Tower Lakes Village Code may also be amended:

- (1) Chapter 4, "Nuisances", of Title 7, "Health and Sanitation", and
- (2) Chapter 3, "Animal Control", of Title 8, "Police Regulations".

Also to be considered are the following amendments to Title 10, "Zoning Regulations", pursuant to the Cannabis Regulation and Tax Act (Public Act 101-027), and specifically, to:

- (1) Section 10-1-3, "Definitions", of Chapter 1, "Administrative Provisions";
- (2) Chapter 6, "General Requirements", to add a new Section 10-6-2, "Adult Use Cannabis Business Establishments Prohibited"; and
- (3) Chapter 4, "Districts Enumerated", to add a new "Article F: Interpretation"

Said proposed amendments to the Village of Tower Lakes Village Code and specifically, proposed amendments to Title 10, "Zoning Regulations", which are part thereof, may be further changed, altered, modified, amended, or redrafted in whole or in part during the course of or after the close of said hearing.

Copies of the proposed amendments are available for inspection at the Office of the Village Clerk, 400 N. Route 59, Tower Lakes, Illinois, during the Village Clerk's regular business hours.

All interested parties are invited to attend this public hearing and will be given an opportunity to be heard.
