NOTICE IS HEREBY GIVEN that the Plan Commission of the Village of Tower Lakes will hold a virtual public hearing on April 14, 2021 at 7:00 p.m., or as soon thereafter as their agenda permits.

In accordance with 5 ILCS 120/7(e)(2) of the Open Meetings Act, as amended by Public Act 101-0640, the Chair of the Village of Tower Lakes Plan Commission has determined that in-person meetings of the Village of Tower Lakes Plan Commission and the general public are not practical or prudent because of the COVID-19 pandemic disaster.

The purpose of this Public Hearing is for the Plan Commission to consider and receive public comment on a proposed 2021 Village of Tower Lakes Official Comprehensive Plan for the Village of Tower Lakes and the Official Land Use Map which is part thereof and include a comprehensive amendment and/or extensive revisions (hereinafter referred to as the "proposed 2021 Village of Tower Lakes Comprehensive Plan"), and to consider related amendments to Section 5-1-1, "Official Comprehensive Plan Adopted", of the Tower Lakes Village Code, which incorporates by reference said Official Comprehensive Plan and Official Map into the Tower Lakes Village Code. Copies of said proposed 2021 Village of Tower Lakes Official Comprehensive Plan and the Official Land Use Map which is part thereof are available for inspection at the office of the Village Clerk, at the Tower Lakes Village Hall, 400 N. Said proposed 2021 Village of Tower Lakes Comprehensive Plan may be changed, altered, modified, amended, or redrafted in whole or in part during the course or after the close of said Plan Commission hearing and before its final approval by the President and Board of Trustees of the Village of Tower Lakes.
